Guide for the Amendment Worksheet

The information provided on this form will be used to calculate the change in value for your breeding animals.

- Partners must report 100 per cent of the partnership's change in value.
- Enter your Participant Identification Number (PIN).
- Enter operation number. If you have more than one operation, complete a separate Amendment Worksheet for each additional
 operation. Identify each operation with successive operation numbers in the box at the top left-hand corner of each page (e.g. Farming
 operation 1 of 2).

Note: If you previously participated in AgriStability, be sure to number each operation in the same order that was used when you submitted this information in prior years.

- Column a Code: Enter the associated code for each breeding livestock item you are listing. Refer to the Inventory Code List found in the Commodity Code Guide.
- Column b Livestock Description: Enter the associated description for each breeding livestock item that you listed in column 'a'. Refer to the Inventory Code List found in the Commodity Code Guide.
- Column c Change in Value (Increase): For each breeding livestock code that you reported an increase to the change in value on your Statement A, report the total value of the increase, as reported to the Canada Revenue Agency (CRA).
- Column d Change in Value (Decrease): For each breeding livestock code that you reported a decrease to the change in value on your Statement A, report the total value (as a positive number) of the decrease, as reported to the CRA.
- Column e Year-end Price: You must provide year-end prices for the livestock inventories that are listed in the Inventory Code List. The year-end price you provide for your commodity must be based on the estimated market prices at year-end. Although it is not mandatory to provide documentation supporting your prices for these commodities, doing so will assist SCIC to process your application and will increase the likelihood of your price being accepted.
- Total Column c: Enter the total of column 'c' values.
- Total Column d: Enter the total of column 'd' values.
- Columns c d: Enter the value of column 'c' minus 'd'. Ensure the amount matches the total dollar amount you reported as the change in value for your breeding animals to the CRA.
